MAY 2015 UCR SUMMARY

In May 2015, the total number of documented uniformed crimes that occurred in Lakeview was eighteen (18) compared to eleven (11) in May of 2014. (See Table Below)

Last month LCPD as a unit handled 808 complaints, 203 residence checks, 353 business checks, 108 traffic stops, issued 102 verbal traffic warnings, wrote 20 traffic tickets, and conducted 106 field interviews. Proactive investigations resulted in 12 arrests for the month.

JUNE 2015 UCR SUMMARY

In June 2015, twelve (12) uniformed property crimes were documented in Lakeview going against nine (09) the previous year, which reflects a **33%** increase compared to June 2014 statistics. There were no persons' crimes recorded in June whereby a person or individual was the intended target.

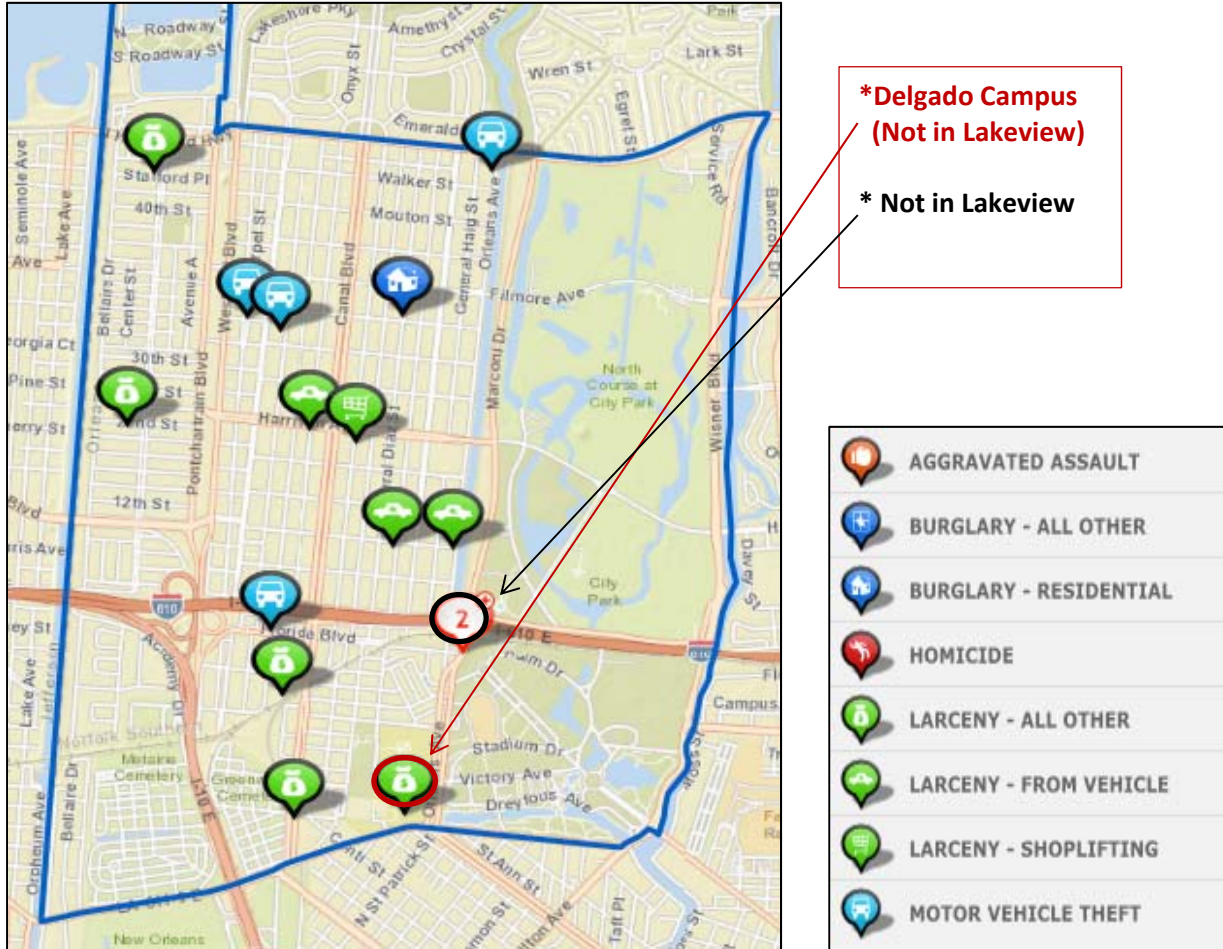

DOOR TO DOOR SOLICITING

Door to Door soliciting is illegal in the City of New Orleans unless the salesperson has in his or her possession a canvassing permit and separate City of New Orleans photo ID which is issued by the Department of Revenue Office at City Hall. Sales representative must have both credentials on his or her person when soliciting. If not, he or she is in violation of city ordinances.

If citizens encounter illegal door to door soliciting, please call 821-2222 and report the incident. LCPD Officers will respond to address the issue along with a representative from the Department of Revenue Office at City Hall.

FALSE ALARM INFORMATION

The false alarm proposal has been passed. The city has not worked out all the details regarding protocol and fees that will be assessed in relation to false alarms police responses.

- Year to date, LCPD officers responded to 1076 false alarm calls for service.
- Accounts for **26%** of all dispatched calls for service in the Lakeview area in June 2015.
- 99% of the dispatched burglar alarm calls were false alarms
